Lorraine Loomis Act – 1838 / 5727

Sec	Summary
2	State policy to permanently protect and restore riparian management zones. Landowners must manage riparian zone to protect riparian function. Exemptions provided.
3	Funding to support implementation, including new SRFBoard grant program and cost share provisions
4	Enforcement provisions, including orders and civil penalties
5	Monitoring program for riparian management zones
6	Incorporating salmon recovery into Growth Management Act and Shoreline Master Programs planning.
